# **MINUTES**

# **ELKHART COUNTY BOARD OF COMMISSIONERS MEETING**

July 19, 2021

President Suzie Weirick called the meeting to order at 9:00 a.m. in room 104 in the County Administration Building, 117 North Second Street, Goshen, Indiana. The other Board members, Frank Lucchese and Brad Rogers were also present. Others present were Craig Buche, County Attorney; Patricia Pickens, County Auditor; Jeff Taylor, County Administrator and Anita Mock, Executive Assistant.

\*\*\*This meeting commenced pursuant to public notice under the Indiana open door law and Governor Holcomb's Executive Orders. This meeting was made available for the public and press to attend in person or engage in remote real-time observation and remote electronic participation.

On a motion made by Brad Rogers, seconded by Frank Lucchese and unanimously carried, the Board approved the Minutes of the June 6<sup>th</sup> & July 12, 2021 meeting and placed them on file, with correction noted for wording in the July 12<sup>th</sup> minutes.

Planning & Development Zoning Administrator, Jason Auvil, requested approval of Ivy Tech Community College of Indiana for an amendment to an existing DPUD R-4 known as **INTERCHANGE DPUD, IVY TECH SECTION**, to allow for new building signage and for approval of all future campus signage to be approved by staff, north side of County Road 18, 1,500 feet west of County Road 17, common address of 22531 County Road 18, in Concord Township. Mr. Buche then presented proposed Resolution No. CO 2021-24 entitled 'Resolution of the Board of Commissioners of Elkhart County, Indiana Receiving and Approving the Petition of Taxpayers Requesting the Leasing of Certain Court and Other Criminal Justice Facilities and Approving Execution of Lease and Related Matters.' On motion made by Brad Rogers, seconded by Frank Lucchese and unanimously carried, the Board approved Resolution No. CO 2021-24.
