MINUTES

ELKHART COUNTY BOARD OF COMMISSIONERS MEETING

November 15, 2021

President Suzie Weirick called the meeting to order at 9:00 a.m. in room 104 in the County Administration Building, 117 North Second Street, Goshen, Indiana. The other Board members, Frank Lucchese and Brad Rogers were also present. Others present were Steve Olsen, County Attorney; Patricia Pickens, County Auditor and Anita Mock, Executive Assistant. Jeff Taylor, County Administrator, was absent.
