Both Parties are required to follow the Family Court Local Rules 400 Series. You should read the entire set of Rules found at Elkhart County Courts under Local Rules. A five-page Highlight Summary is required to be attached to this Summons, but a full reading of those Rules is highly recommended.

The Elkhart County Family Court expects cooperation and communication, especially when children are involved. It is best if you and the other parent can work out as many agreements as possible prior to your first appearance in court. If you and the other parent are unable to work together, expect to attend a Problem-Solving Settlement Conference within 45 to 60 days of receiving this Summons, unless otherwise waived by the Court; or, within 45 to 60 days of adjudication of paternity.

If the parties signed a Paternity Affidavit at the time of the child's birth, paternity has been established. If the Petition is seeking child support you are required to provide evidence of your weekly gross income (your pay before any deductions) and documents to verify year-to-date income (pay stub or

employer statement) and your last income tax return, including all W-2s, 1099s and all accompanying schedules. There should be a Subpoena attached with the specific financial information that is essential to making these decisions.
