AGEED ORDER ESTABLISHING GRANDPARENT VISITATION

The Court having reviewed the Petition for Grandparent Visitation, now finds the following:

1. The Court has jurisdiction over this matter pursuant to I.C. 31-17-5.
2. The Petitioner(s) is/are the maternal / paternal grandparent(s) of the minor child(ren).
3. The Respondent(s) are the parents of the minor child(ren).
4. The minor child(ren) are:

5. The grounds for the Petition are:
 - The minor child(ren)'s Mother / Father is/are deceased.
 - The marriage of the minor child(ren)'s parents has been dissolved in Indiana.
 - The child(ren) was/were born out of wedlock, and:
 - The person filing is a paternal grandparent and the father has established paternity.

-OR-

 - The person filing is a maternal grandparent.

6. The Court, having considered the evidence finds that granting grandparent visitation is in the best interests of the Minor Child(ren). The Court considered the following factors:

- a. The nature, quality, and history of the relationship between the grandparent(s) and the Minor Child(ren);
- b. Whether the grandparent(s) have had or tried to have meaningful contact with the Minor Child(ren);
- c. The wishes of the Minor Child(ren);
- d. The stability of the Minor Child(ren)'s current environment, home, school, and community;
- e. Any risk that visitation would disrupt or interfere with the Minor Child(ren)'s normal routine or cause conflict;
- f. The fitness of the parent(s) and the weight given to their preferences, with a presumption in favor of a fit parent's decision;

7. That grandparent visitation with the minor child(ren) shall be as follows:

8. The Parties may request a modification of this Order. The Party seeking modification must show clear and convincing evidence of a change in circumstances justifying the modification.

9. This Order for visitation remains subject to further Orders from this Court.

10. If any party violates this Order without good cause, that party may be held in contempt of court or subject to sanctions.

11. If a final adoption is entered for the Minor Child(ren), this visitation Order may terminate or be subject to the statutory limits.

WHEREFORE, all parties waive their right to a hearing, request that the Court grant this petition for grandparent visitation, and order all other relief that is just and proper in the premises.
