All information placed or retained in any state central repository for criminal history information or in any other alphabetically arranged criminal history information system maintained by a local, regional or statewide law enforcement agency shall be removed by the following agencies: **ELKHART COUNTY, INDIANA SHERIFF’S DEPARTMENT; ELKHART, INDIANA POLICE DEPARTMENT; GOSHEN, INDIANA POLICE DEPARTMENT; ELKHART, INDIANA COUNTY JAIL; ELKHART COUNTY ADULT PROBATION OFFICE; INDIANA STATE POLICE; AND ALL OTHER AGENCIES ASSOCIATED WITH THE LISTED CASES.**
2. All records of the sentencing court, juvenile court, the Court of Appeals, and the Supreme Court concerning the Petitioner shall be redacted or permanently sealed.
3. Nothing in this Order should be construed to prevent the Indiana Bureau of Motor Vehicles from reporting information about a conviction for a violation of a traffic control law to the Commercial Driver’s License Information System (CDLIS) in accordance with I.C. 9-24-6-2(d).
4. **The Clerk shall send a copy of this Order to all parties of record and their counsel; the Indiana Department of Corrections, the Indiana Bureau of Motor Vehicles, the Indiana State Police Central**

Repository for Criminal History, and the following law enforcement agencies or entities that incarcerated Petitioner: ELKHART COUNTY, INDIANA SHERIFF'S DEPARTMENT; ELKHART, INDIANA POLICE DEPARTMENT; GOSHEN, INDIANA POLICE DEPARTMENT; ELKHART, INDIANA COUNTY JAIL; ELKHART COUNTY ADULT PROBATION OFFICE; AND ALL OTHER AGENCIES ASSOCIATED WITH THE LISTED CASES.
