The meeting of the Elkhart County Council was called to order by Sheriff Jeff Siegel at 4:00 p.m., in Room 104 of the County Administrative Building, Goshen, Indiana. Members present were Council President Thomas W. Stump, Darryl J. Riegsecker, Douglas S. Graham, Randall D. Yohn, Adam M. Bujalski and Steven E. Clark. Council Vice President David L. Hess arrived late. Also present were Patricia A. Pickens County Auditor, Tiara Jackson First Deputy Auditor, and Craig Buche, County Attorney.

COUNCIL: Yohn spoke on the passing of Longtime Elkhart Historian Paul Thomas and his contribution to Elkhart City and Elkhart County.

Clark spoke on meeting with the Sheriff and Under Sheriff and the positions at the Jail, with some of the risks involved with those positions. Stated his appreciation on the people who fill those positions every day.

Bujalski congratulated Fairfield Girls Basketball and Northwood Boys on their State Championships. He also commended 14 students from Northwood was part of the Robotics Team that qualified for the World Championship in Dallas.
