MINUTES

ELKHART COUNTY BOARD OF COMMISSIONERS MEETING

May 8, 2023

President Brad Rogers called the meeting to order at 9:00 a.m. in room 104 in the County Administration Building, 117 North Second Street, Goshen, Indiana. The other Board members, Suzie Weirick, was absent and Bob Barnes was also present. Others present were Craig Buche, County Attorney; Patricia Pickens, County Auditor; Jeff Taylor, County Administrator and Kelly Ropp, Administrative Manager.

***This meeting commenced pursuant to public notice under the Indiana open door law and Governor Holcomb's Executive Orders. This meeting was made available for the public and press to attend in person or engage in remote real-time observation and remote electronic participation.

On a motion made by Bob Barnes, seconded by Brad Rogers and unanimously carried, the Board approved the Allowance of Claims as presented by the County Auditor's office.

On a motion made by Bob Barnes seconded by Brad Rogers and unanimously carried, the Board approved the Minutes of the March 27th, 2023, meeting and placed them on file.

BUSINESS ITEMS:

John Bowers, Landfill, requested receipt of Proposals for Landfill Gas Recovery Project. The proposals will be ranked in order and consideration will be taken for a long-term commitment. Five proposals were received. On motion made by Bob Barnes and seconded by Brad Rogers and unanimously carried by the board, to accept and release the bids to the Energy Committee, to review the bids and accept the proposals.

Herman & Goetz, Inc., Cable Electric, LLC, Timpi Electrical Solutions LLC, Mechanical Man, L & M Electric, Inc. and Anglin Electric. On motion made by Bob Barnes and seconded by Brad Rogers and unanimously carried by the board, the Board approved this request.
