## ADDITIONAL APPROPRIATION EXPLANATIONS:

## A. GENERAL FUND (#1000)

- 1. Commissioners (130) requested \$ 3,700,000.00 be appropriated for the following:
  - 1. \$2,200,000.00 for the new Courthouse furniture & fixtures for each office and throughout the building.
  - 2. \$1,500,000.0 for the Audio/Visual needs for each courtroom.

Jeff Taylor explained to the Council the source of funding for this request are the interest earnings on the ARP funds and the bond funds for the Courthouse.

Graham stated he had the understanding the new total amount for the courthouse Project was not to exceed \$112,000,000.00 He stated with this appropriation the total would be \$35,000.00 over the \$112,000,000.00. Clark joined in the discussion.

On motion made by Graham to reduce the line item for furniture and fixtures from\$ 2,200,000.00 to \$1,165,000.00 thus reducing the original amount of \$3,700,000.00 to \$3,665,000.00 to approve and seconded by Clark, the Council unanimously carried and approved this motion with a vote of 7 to 0. (pg. 374)

#### B. JAIL CAGIT (#1114)

1. Building and Grounds (140) requested \$100,000.00 for building/plumbing/electrical and HVAC repairs to the jail.

Jeff Taylor and Commissioner Bob Barnes presented this request to the Council.

On motion made to approve by Graham and seconded by Bujalski, the Council unanimously carried and approved this request with a vote of 7 to 0. (pg. 375)

#### C. CUMULATIVE BRIDGE (#1135)

1. Highway (980) requested \$140,000.00 for funds to remove and replace the concrete deck on Bridge 310 -CR 21 over Swoveland Ditch, located just north of CR 142.

Charlie McKenzie explained to the Council the deck has failed and requires frequent patching, which leads to further deterioration of the beams. Replacing the deck now will preserve the beams and maximize the life of the bridge.

On motion made to approve by Graham and seconded by Bujalski, the Council approved this request with a 7 to 0 vote. (pg. 376)

## D. LOCAL PUBLIC HEALTH SERVICES (#1161)

1. Health Department (980) requested \$2,460,921.00 to set up proposed Local Public Health Services for 2024.

Melanie Sizemore presented this request to the Council.

On motion made to approve by Graham and seconded by Bujalski, the Council unanimously carried and approved this motion with a vote of 7 to 0. (pg. 377)

## E. MAJOR MOVES (#1172)

1. Commissioners (980) requested \$2,900,000.00 for Road Improvement Project for the Courthouse Construction in cooperation with the City of Goshen. (Reliance Road, CR 28 & CR 17).

Jeff Taylor presented this request to the Council.

On motion to approve made by Riegsecker and seconded by Bujalski, Council member Graham asks for a roll call vote. The council member votes are as follows: Stump-Aye, Hess-Aye, Clark-Aye, Graham-Nay, Yohn-Aye, Riegsecker-Aye and Bujalski-Aye. With a vote of 6 to 1, the Council carried and approved this request. #### F. MOTOR VEHICLE HIGHWAY (#1176)

1. Highway (980) requested \$15,000.00 for funds to replace two overhead garage doors at CR 7 facility that houses Highway, Sheriff's office, Weights & Measures and the Emergency Management Department.

Kyle Wagner presented this request to the Council.

On motion made to approve by Riegsecker and seconded by Clark, the Council unanimously carried and approved this request with a vote of 7 to 0. (pg. 380)

#### G. WESTERN GATEWAY TIF (#4506)

1. Planning & Development (980) requested \$6,341.47 for payment on loan to the Western Gateway TIF District being fund 4605 pursuant to resolution of the Elkhart County Redevelopment Commission with a pledge of 95% of the TIF revenues for 2022 pay 2023 Spring installment.

### H. NORTH BAUGO TIF (#4512)

1. Elkhart County Judiciary (980) requested \$4,546.88 be appropriated to be able To cover expenses for the annual Children's Summit.

Ross Maxwell presented this request to the Council.

On motion made by Graham to approve both items L. Children's Summit Program Fund (#4930) for \$4,546.88 and Item M. Court Improvement Grant (#8122) for \$4,546.88 together since they are transferring funds out of one fund to put in the other fund and seconded by Bujalski, the Council unanimously carried and approved this this motion with a vote of 7 to 0.
