2. Defendant is to contact Plaintiff's counsel at phone number enter phone number or appear in person at the office of enter office located at enter address.
3. Defendant is required to be available for 45 minutes from the scheduled time to answer questions as to the Defendant's income, assets, and non-exempt property. **Failure to be available for the telephone call or failure to appear for the meeting if at counsel's office, will be treated as a failure to appear.**
4. If the Defendant cannot be available at the scheduled time, it is the responsibility of the Defendant to contact Plaintiff's counsel and make alternative arrangements for the meeting by calling, enter phone number. Plaintiff's counsel is to respond promptly to any inquiry by the Defendant.
5. If the Defendant does not wish to talk with Plaintiff's counsel, the Defendant must file, in writing, a request for a hearing with the Court no less than 7 days **BEFORE** the meeting. (Petitions can be picked up in Superior Court #5 Clerk's Office.)

Plaintiff shall serve copies of this Order on all parties in accordance with T.R. 5(H)(2).
