### **MINUTES**

### ELKHART COUNTY BOARD OF COMMISSIONERS MEETING

# **April 1, 2024**

President Brad Rogers called the meeting to order at 9:00 a.m. in room 104 in the County Administration Building, 117 North Second Street, Goshen, Indiana. The other Board members, Suzie Weirick and Bob Barnes, were also present. Others present were Craig Buche, County Attorney; Tiara Jackson, First Deputy Auditor; Jeff Taylor, County Administrator and Kelly Ropp, Administrative Manager.

On a motion made by Suzie Weirick seconded by Bob Barnes and unanimously carried, the Board approved the Minutes of the March 18, 2024, meetings and placed them on file.

On a motion made by Bob Barnes, seconded by Suzie Weirick and unanimously carried, the Board approved the Allowance of Claims as presented by the County Auditor's office.
