MINUTES

ELKHART COUNTY BOARD OF COMMISSIONERS MEETING

May 13, 2024

President Brad Rogers called the meeting to order at 9:00 a.m. in room 104 in the County Administration Building, 117 North Second Street, Goshen, Indiana. The other Board members: Suzie Weirick was absent, and Bob Barnes was present. Others present were Craig Buche, County Attorney; Patricia Pickens, County Auditor; Jeff Taylor, County Administrator and Kelly Ropp, Administrative Manager.

***This meeting commenced pursuant to public notice under the Indiana open door law. This meeting was made available for the public and press to attend in person or engage in remote real-time observation.

On a motion made by Bob Barnes, seconded by Brad Rogers and unanimously carried, the Board approved the Minutes of the April 29th, 2024, meeting and placed them on file.

On a motion made by Bob Barnes, seconded by Brad Rogers and unanimously carried, the Board approved the Allowance of Claims as presented by the County Auditor's office.

BUSINESS ITEMS:

Charlie McKenzie, County Highway, received bids for the 2024 CCMG Paving Program. Three bids were received. Reith Riley, South Bend, Base bid is \$3,088,426.64, Alternate Bid is \$263,299.95 for a total of \$3,351,726.59. Niblock Excavating, Bristol, Base bid is \$2,987,420.90, Alternate Bid is \$259,730.20 for a total of \$3,247,151.10. Milestone Contractors, L.P., South Bend, Base bid is \$3,996,000.00, Alternate Bid is \$382,000.00 for a total of \$4,378,000.00. A motion made by Bob Barnes, seconded by Brad Rogers and unanimously carried, the Board approved to accept the bids and have staff review them. (Page 663)
