A. EDIT (#1112)

On motion made by Yohn and seconded by Riegsecker, the Council unanimously carried this request and the appropriation was approved.

B. LIT SPECIAL PURPOSE (#1114)

1. Building and Grounds (140) request \$75,000.00 for building repairs at the jail.

Tom Byer explained to the Council that this is also to be used to help update/ and the maintenance on all jail buildings at the Criminal Justice Complex.

On motion made by Riegsecker and seconded by Stump, the Council unanimously carried this request and the appropriation was approved.

C. CUMULATIVE CAPITAL DEVELOPMENT (#1138)

1. Commissioners (980) request \$175,000.00 to be utilized by the Building & Grounds Department to make maintenance/repairs to all county owned buildings.

Tom Byers presented this request to the Council and after asking for \$175,000.00 reduced the amount to \$150,000.00.

D. ECONOMIC DEVELOPMENT FEE (#1149)

1. Commissioners (130) request 12,000.00 for an investment in Regional Economic Development Strategy.

E. LOCAL ROAD AND STREET (#1169)

1. County Highway (980) request \$330,000 for expenses related to crack seal of roads including, but not limited to machine rental.

Jeff Taylor presented this request to the Council.

On motion made by Riegsecker and seconded by Stump, the Council unanimously carried this request and approved the appropriation.

F. MOTOR VEHICLE HIGHWAY (#1176)

- 1. County Highway (202) requests \$100.000 for funds needed to pay other professional services.
- 2. County Highway (980) request 65,000 for funds needed for buggy plates, stickers, supplies and paying for Interra for sales, replace roof on salt barn on CR 35.

Jeff Taylor explained this request to the Council. *Glenn Null questioned the buggy plate process.

On motion made by Stump, and seconded by Riegsecker, the Council unanimously carried these request and approved both appropriations.

G. STORM WATER MANAGEMENT OPERATING (#1197)

1. County Highway (202) request \$160,000 for funds to perform required MS good housekeeping components, which may require some (subcontracting) Jeff Taylor presented this request to the Council.

On motion made by Stump and seconded by Riegsecker, the Council unanimously carried these request and approved the appropriation.
