II. Miscellaneous Items- 2017 Budget Item Review

Included in your personal services data from Human Resources, you will see the spreadsheet titled Summary of Requests not Equal to Guidelines. Most of these exceptions or variances are due to department heads projecting 3 and/or 6 month increases and making adjustments for other staffing changes that occurred between the time the 144 supplemental detail was generated and when it was submitted.

A couple of departments are leaving positions unfunded for 2017. The Recorder's office is continuing to leave two positions vacant and unfunded for 2017, totaling \$41,560. Court Services is leaving two positions unfunded for 2017 in their user fees fund. These are not potential cuts.

There are some exceptions that we have no control over, such as Probation Officers, due to the state guidelines for their pay.

There are variances/exceptions in both Sheriff's Department and PSCC. These are due in part to the new compensation systems they are using as well as confusion when the budgets went out. My recommendation, if you approve the 3% increase the Sheriff is requesting, is to approve their budgets as requested.

Items for your consideration and recommendation to full Council:

- A. Sheriff's Department approve new wage schedules which include a 3% adjustment, as well as the 1% longevity previously approved.
- B. Assessor's Office The account for technicians was over-budgeted. \$130,303 can be cut.
- C. Council Increase of \$3000 in various additional duties pay.
- D. Circuit Court Juvenile request additional 3% increase for all staff.

E. Court Services – transferred a grant funded Probation Officer (Horton) from Grant 9113 to General Fund in May. The recommendation was that we needed to look at this at budget time to see if it can permanently stay in General Fund in 2017 or not.

A Probation Officer (Olson) was moved from User Fees to a vacant General Fund position.

The two salaries together total \$86,424.

The budget comments from the department say "2 <u>new PO</u> positions added to budget when preparing budget for Intake/Resource Center". After further discussion with Bob Girard, it appears that the positions are not new but will be reclassifications of two current vacant positions. Also, Olson actually replaced A. Letherman, but both salaries were included in the budget, so there is a little "wiggle room" if the two reclassifications require additional monies.

- F. PSCC and E911 requesting 1% pay increase; no PIP as per agreement when new compensation program was approved.
- G. Park Department- requesting individual rate increases for one Interpretive Services II and one Park Services III employee, totaling \$8554. The reasoning behind the individual rate increases is to bring them more in line with others in the same position. This was heard earlier in the meeting and is included in their 2017 budget.

H. New Positions -

Public Defender- has a new FT Public Defender that was previously approved at CCPC in May. Funding for this position is included in his budget and increased his personal services account by \$56,049. When it was approved by CCPC, he was asked to see if he could fund the position in their supplemental fund instead of General fund and discuss at budget time.

Park Department- has a new Park Services III position (Boot Lake Manager) that was approved by CCPC last month. Funding for this position is included in their budget for 2017, as well as the reclassification of their Secretary position.

Superior Court #3- Has a new Transcriptionist position that was approved by CCPC last month. This request is not in their budget and is therefore not in the Summary of Requests Not Equal to Guideline.

Planning and Development/Code Enforcement- One new RPT Planning Assistant and one new RPT Planner III were approved by CCPC last month and are included in their 2017 budgets.

Court Services- See letter E above.
